RESOLUTION

FOR ADDITION TO SECONDARY ROAD SYSTEM

WHEREAS, the attached investigation report for the addition of Saybrook Drive and Ashley Pond Court to Ashley's Ponds Subdivision has been filed with the Board of Commissioners for the County of Alamance requesting that said roads should be added to the Secondary Road System; and

WHEREAS, the Board of Commissioners for the County of Alamance is of the opinion that the above-described roads should be added to the Secondary Road system, if the roads meet the minimum standards and criteria established by the Division of Highways of the Department of Transportation and Highway Safety for addition of said roads to the system.
